- Administrative Claiming Filed 70 original and 57 amended administrative claims (due to a retroactive rate change) totaling \$1,166,565 returned to school districts during the fiscal year (up from \$1.13 million in FY2015).
- Direct Service Claiming: Returned over \$2.1 million to school districts during FY16 for Direct Service Claiming.



• Introduced reimbursement for Autism Services to school districts participating in program. Currently 7 districts out of the 18 have at least one ABA provider with Medicaid-eligible credentials, and we are expecting this to increase in 2017.

## **Transportation**

- John Gaucher has assumed his new role as Transportation Manager. John comes to ACCEPT from First Student and brings with him a wealth of relevant experience. In his first few weeks he has identified opportunities for improvement and is addressing them prior to the start of school in the fall.

#### **Programs**

- We received the Mid-Cycle Review from DESE and I am pleased to report the Collaborative was found "to be in compliance with all the criteria monitored."
- The Extended School Year Program is well under way with a total of 101 students enrolled. Our theme this summer is "Go ACCEPT Go." The curriculum and activities are focused on the Olympics.



# **Professional Development**

I am pleased to report ACCEPT was awarded a multi-year grant from DESE to conduct the New Special Education Leadership Institute. This year's process was totally revamped and highly competitive. The Institute will take place August 8 – 10 at the Hampton Inn, with 5 follow-up sessions scheduled throughout the year.

### **Facility Update**

At the RFP deadline one proposal was received. Garry Holmes submitted a comprehensive proposal for the property at 4 Tech Circle, Natick. Per our discussion at the June meeting, Dan reviewed the proposal and agrees this property is a viable option to house programs, professional development, and office space. There is also adequate, on-site parking. The location in MetroWest is perfect in terms of proximity to our member districts and provides convenient access to a number of highways. I have arranged a tour of the building for members of the ACCEPT leadership team on August 4 at 1:15 and invite you to join us. Please let me know if you plan to attend. I am excited about moving forward and the promise this holds for the Collaborative's future.

#### Other ED Activities:

- As part of the Community Action Partners (CAP) application process a team
  interviewed various ACCEPT stakeholders; a special thanks to David Lussier and
  Dan Gutekanst for participating. As a reminder, CAP is a volunteer organization of
  Harvard Business School (HBS) and Harvard Kennedy School alumni helping
  Boston-area nonprofits apply management skills to their business challenges. More
  than 100 alumni volunteers serve 13-16 nonprofits each year. A final decision on
  our application will be made in the fall.
- Interviewed architects in preparation for moving forward with the building project
- Toured other collaboratives that have their own facilities for information gathering
- Interviewing, hiring, and orienting key staff
- Updating manuals and handbooks
- Attended the M.A.S.S. EI
