Attached please find the expenditure report for the school department general appropriation including all expenses posted through November 15, 2019. All expenses are categorized into salary accounts and non-salary accounts, so when I use the broader term expenses, it would be inclusive of salaries. Reclassifications from revolving accounts will occur throughout the year, however, until they are completed, you may notice a negative balance on this report. Budgeted use of revolving funds is \$4,872,835.
