Re: New Club Request - Footlighters

An action item is presented for your approval to establish a Middle School Musical Drama Club called Footlighters. This club was in existence until it was discontinued about three years ago at the request of the principals given the waning interest in the musical production. The assets in the account at that time were distributed evenly to all three middle school student activity accounts.

Given the renewed student interest among all three middle schools in putting on a performance, the Music Director and the Principals are in agreement that they would like to reinstate the Footlighters club. Startup funds for licensing for the first musical will come from the schoolwide student activity accounts at each middle school. Revenue generated from ticket sales to performances, ad booklets, donations, etc will be accounted for in the ASMS student activity fund. Stipends to advisors for oversight of this club will be budgeted by each school for FY19 and paid in accordance with the collective bargaining agreement. Expenses for the production will come from the student activity account and will not exceed revenue generated.

I recommend the establishment of the Footlighters student activity sub-account for the purpose of a middle school musical production and in accordance with the guidelines issued by the Department of Elementary and Secondary Education.
