Approximately 2/3rds of our cases are not reported at the DESE level because a majority of individuals are not in the school buildings 7 days prior to the report of their case. This is because they had been in quarantine as a close contact or they had been remote due to the hybrid schedule. As a result of this trend, the number of close contacts identified in the school setting has kept our close contact numbers very low.

Open Questions

- 1. Will we be able to maintain enough staff in our schools to supervise in person learning as case counts climb and more staff members need to quarantine due to personal situations or school-related cases?
- 2. How can the district support staff to sustain the demands of teaching and learning in the hybrid and remote environments?

Teaching and Learning

- 1. Structured Learning Time. The Department of Elementary and Secondary Education has set new requirements for synchronous learning time in hybrid and remote learning models. Franklin Public Schools is preliminarily cleared as we are meeting the minimum requirement, on average of 35 hours per 2 week period in the hybrid setting and 40 hours per 2 week period for remote.
 - Actions taken: Principals are sharing SLT information with faculty and staff to keep them informed. Adjustments may be made, if needed, on a case by case basis.
 - Actions planned: We will submit SLT data when DESE follows-up in February.
- 2. Changes to MCAS 2021. DESE announced changes to MCAS for 2021 which are summarized as follows:
 - Modified competency determination for class of 2021.
 - Shortened testing time for grades 3-8.
 - Accountability relief related to under performing schools.
 - Extending ACCESS testing window.
 - Flexibility on MCAS Grade 9 Biology test scheduling.

Whole Child Supports

- 1. Food Services. Families eligible for free and reduced lunch will receive Pandemic EBT benefits starting this week, which will occur throughout the remainder of the school year. Benefits vary based on the instructional model. (Fully remote \$117.20 per month; hybrid is \$58.60 per month; half-day or fully in person is not eligible).
 - a. Actions taken: Notification letters which describe how to access benefits are being sent to families on Friday January 8, 2021.

Personnel

1. Staffing. As case numbers rise, we continue to hear about worries and concerns about COVID positive cases within the community. We are striving to remain connected to the worries and concerns of our faculty/staff and be responsive wherever possible.

Health and Safety

- **1. Pool Testing.** On Friday, Governor Baker and Commissioner Riley announced classroom based pool testing will be available for Massachusetts public schools.
 - a. Actions planned: We will continue to conduct ongoing research into surveillance and diagnostic testing, including attending the informational webinar DESE is offering. We will need to survey families and staff about willingness to participate in pool testing, the efficacy of which is dependent on having enough people willing to participate.
- **2. HVAC**. UVGI has been installed at Franklin High School with final work being completed on setting up the automatic controls. "Large unit" installation at the complex schools is underway. Air purifiers have been distributed across the district. As an added measure, units are also being placed in the complex schools even in locations where UVGI will be installed.
- 3. Vaccine Clinic. Franklin is hosting a vaccination clinic for first responders from 5 regional towns on Wednesday, January 13 and Wednesday, January 20 in the gymnasium. We are so thrilled to be part of the rollout, which will allow us to learn and observe as we begin planning for phase II of vaccine distribution, which includes early childhood and K-12 educators. School nurses are now permitted to receive the vaccine in phase I.
 - a. Actions planned: Develop a schedule for our school nurses to be vaccinated in phase I.
