#### Superintendent's Report to School Committee January 22, 2019 School Committee Meeting

## Weather Conditions

I would like to thank our DPW and facilities staff for the diligent work and communication over the weekend. This storm had been particularly difficult to clean up after, given the accumulation of snow, followed by sleet, and the rapid overnight freeze on Sunday evening. The prolonged cold limits the effectiveness of salt and sand, leaving ice on streets, sidewalks, and parking lots. I also want to thank the staff, students, and families for patience in arrival today.

We instituted Emergency Busing and on mornings such as these, we are lenient with attendance in our understanding that arrival takes time under these conditions. We will continue Emergency Busing for Wednesday, January 23.

Again, we want to thank everyone for their patience.

## Franklin Cultural District

This announcement has previously gone out but I want to make sure you are aware that the Franklin has been awarded Cultural District Status by the State of Massachusetts. It was a unanimous vote of the Massachusetts Cultural Council, making Franklin the 46th Cultural District in the state. This status makes the FCD eligible for a variety of state grant programs, state economic development opportunities and monies, strategic planning and historic preservation assistance, and marketing through the Massachusetts Office of Travel and Tourism.
