E. Superintendent's Report

Mr. Giguere spoke about the food recycling program and how 70.7 tons of waste have been removed from regular waste since implementation of the program.

This information will be also shared at the Town Council meeting.

He spoke about the 200 FHS seniors who are participating in the Senior Project, a 70 hour internship in an area of study that is of interest to the student.

Presentations will take place on 5/21/24.

He gave a school facilities assessment update. He said there have been a series of forums designed to gather stakeholder feedback and workshops to engage all the school levels and the community. He noted that there is a half-day on 4/14/24. Finally, he wished everyone a safe and restful break.

Mr. Callaghan asked the committee for any questions/comments from the committee?

Mr. Griffith said it is important for the community to understand about the

master facilities plan and have community engagement.

Mr. Charles asked if 70.7 tons are just for FY24 or since the program started? Mr. Giguere replied that to his understanding it is the total since the program started.

Mr. Charles asked about cost saving to the district

Mr. Giguere replied that he doesn't know the cost savings at this time but will find out.

Mr. Charles asked about the possible concept of transitioning to real silverware from plastic in the cafeteria.

Mr. Giguere replied that the idea has not passed by his desk as of yet.

Mr. McNeill shared the enthusiasm for the recycling program and asked when it began?

Mr. Giguere replied that it began last fall at ASMS, last winter at Remington, and last spring at HMMS.

Ms. O'Sullivan said the middle school students are excited about senior projects that will take place within the middle school music programs.

Mr. Sompally spoke about cost savings with the food service program.

Mr. Giguere replied that people appreciate the food service program and praised the Food Service Director, Colin Boisvert.

II. Guests/Presentations

A. Horace Mann Highlights Ms. Becky Mottie and Ms. Jenn Santosuosso *See presentation slides for more detailed information

Ms. Motte spoke about the Six Pillars of Character, district goals and middle school goals.

She spoke about community partnerships such as Franklin Public Library, the Franklin Cultural Council, visiting authors, and team building at the YMCA.

Ms. Santosuosso spoke about visiting author Jordan Sonnelbleck and how he engaged the students through small group sessions.

Ms. Motte spoke about the School Resource Officer, Amanda Ayer and how she contributes to HMMS.

Ms. Motte spoke about community and citizenship such as peer leaders, organizing food drives, and Unified Basketball.

Ms. Motte also spoke about their PCC partnership. She talked about the recent winter social in January and the yearbook.

She also spoke about field trips at each grade level.

She discussed Open Sci Ed, UDL, and Project Based Learning.

Finally, she spoke about rigorous and engaging curriculum and high quality instruction.

Mr. Callaghan asked the committee for any questions/comments from the committee?

Mr. Sompally asked about anti-bullying programs?

Ms. Motte replied there is a small component through the YMCA trip, an anti-bullying unit in health class and a social emotional curriculum called Second Step.

Ms. O'Sullivan asked about the LGBTQ community and no longer having a club specific for this group?

Ms. Motte replied that it is unfortunate that the club is not happening. She added that they have been able to incorporate these lessons through their advisory program.

Ms. O'Sullivan noted that having the school send out resources on specific topics would be helpful as well.

Ms. Motte replied that that is a good idea and noted their Student Services staff is available to the HMMS students and families.

Ms. O'Sullivan also noted that the middle school students enjoy having the high school students to partner with on different occasions.

Ms. Motte agreed and noted that the SCOPE club at FHS just put on an event for middle school students.

Mr. McNeill praised them both for their accomplishments at HMMS this year.

Mr. Charles praised their work centered around literacy.

Mr. Charles asked about the YMCA team building program and how it is funded? Ms. Motte replied that there is a partnership with the YMCA and the only cost to HMMS is for the buses to transport the students.

Mr. Griffith noted that he appreciates the fact they are engaging the students in complex areas of science that are typically presented in high school.

Mr. Callaghan said that the town administrator will be releasing his recommended budget on Friday. He added that there is a town council meeting on 4/10/24.
