# 4. Discussion Only Items

a. Summer Professional Development and Curriculum Update

Dr. Edwards - As you know the principals not only work over the summer, teachers do as well. I did a similar presentation last year, and it was directed by the district. About 5 years ago we did a proposal form for work they would want to do.

Brief History - Teacher's submit a proposal and we let them know by March if they have been accepted. Can't fund all proposals. They are trying to do work they can't do during the school year. All the work is monitored and work products prior to getting the stipend.

Funding - We funded \$37,000 and \$7,000 was out of special education. This is comparable to previous years.

ECDC is working on report card development using materials from a new program.

Elementary Level -

We had teachers working on reading and writing. Literacy specialist did some work that they will introduce this year.

In science, they are working on science unit plans and STEM scopes.

Math specialist were working on individual profiles of students. Work on a website, word problems.

Music department did some curriculum work.

Dr. Bergen - If individuals do a project, is it shared?

Dr. Edwards - They work as a team, not alone. It is shared in google drive.
