- D. Superintendent's Report

Dr. Ahern addressed information about school surplus and materials that was brought up at the last School Committee meeting on August 11.

Dr. Ahern shared the reopening update and FPS is actively getting the schools ready. She thanked all the staff who are helping with this challenge to get the schools up and running. The official date for staff to return is Monday, August 31 and they will be experiencing professional development.

Dr. Ahern shared that the new teacher orientation is currently happening.

She also stated that the request for busing has expired but that is a fluid situation and will be continuing to collect busing requests. She asked that people wait to pay for busing..

She shared that they might be changing some of the dates for the high school reopening. She stated that they are considering revising the target dates for the hybrid model.

Lastly, Dr. Ahern stated that the flu vaccine will be required for all students whether remote or in-school learning.

Ms. Scofield asked about the high school's new dates. She also asked about considering having the high school start later. She also asked if there will be enough slots for teachers who need daycare.

Dr. Edwards responded that they are getting inquiries.

Ms. Spencer asked about when parents can see more information for families.

Dr. Ahern stated more specifics will follow up in the coming weeks.

Ms. Spencer asked about teacher assignments.

Dr. Ahern said we are working on those.

Ms. Spencer expressed a safety concern about special education and masks.

Mrs. Marano addressed the mask issue for meetings with special services and that face shields with masks will be required.

Mr. Keenan asked about DESE guidance about teachers being in classrooms during remote times that those benefits did not seem substantial. He stated a concern about child care for teachers and how remote learning could be affected.

Ms. Pond-Pfeffer wanted to share that she would like to see the teachers in the classroom and teachers could ask for a leave of absence and what could happen.

Ms. Stokes also asked about the child care issue for staff and that it is expensive.

Dr. Ahern stated they will take that under consideration.

Ms. Stokes asked if the school based implementation teams were still meeting. Dr. Ahern indicated that they are.

Dr. Bergen stated that the YMCA is also providing daycare services at a reasonable rate.

Ms. Spencer wanted clarification on a communication that went out was it for remote only.

II. Guests/Presentations

A. Tom Angelo, FHS Athletic Director Josh Hanna, FHS Principal

Mr. Angelo provided information about the MIAA and DESE and their guidelines and categorized them into low, medium and high risk. They then divided the year into four different seasons. He spoke about how the athletic directors meet regularly and spoke about how the decisions are being made throughout the Hockomock League.

Mr. Hanna also spoke about the proposals for athletics and how we can have live athletics at this time and that all the adjustments will be made to the sports to protect the student athletes.

Ms. Scofield inquired about soccer and that it is a medium risk as it was considered a high risk previously.

Mr. Angelo stated that there would be modifications put into place.

Ms. Scofield asked about the cost of transportation for athletics and if parents will be transporting students, has it been run through the legal department?

Dr. Ahern clarified the transportation portion.

Ms. Spencer also echoed concerns about the modified practices for field hockey and soccer.

Dr. Ahern spoke about the athletic fees.

Mr. Keenan commented that he would advocate for athletics to continue. He stated that remote learning might allow athletics to be safer at this time.

Dr. Bergen spoke about how the recreation department was able to hold sports over the summer and that she supports this.

Will Tracey is a member of the football and basketball teams. He thanked everyone for their support. He stated he was extremely disappointed that school and some sports were postponed.

Gigi Zub thanked everyone. She spoke about soccer and how students have been practicing and playing soccer.

Declan Walmsley is a student athlete and would like to have sports continue as well clubs and activities.

Sydney Hawkins runs cross country and supports having athletics continue.

Denise Lewandowski, a parent, stated that the students have said it well. This will give students a glimmer of hope.

Virna O'Brien spoke about the well being for the class of 2021 and how they are the lost class.
