A. Review of Agenda - reviewed - all is fine

B. Citizen's Comments - none

Donna Grady, President of FEA, spoke as a teacher and President of FEA and spoke about a SC meeting a few weeks ago and reminded us that we need to bring kindness and grace. She described how the schools are doing and how much work the school nurses are doing during COVID. She asked that we reframe how we think about what students have lost and instead of what we are trying to do, keep them safe, learn online and keep their spirits up.

Michelle Brent agreed with Donna and provided insight into the counseling for students. She spoke about having the power to control what we do and that the priority is keeping the students safe. She continued to speak how trauma is affecting students and staff. She is a trauma counselor.

A. FHS Student Representative Comments

Akash Shetty agreed with the previous comments. He spoke about a meeting with Mr. Hanna about upcoming events. He said not much is happening.

B. Superintendent's Report

Dr. Ahern shared information about the Department of Education and the requirements for remote settings and hybrid. She spoke about the fact that Congress approved a stimulus package and FPS will have the CARES Act Funding deadline to be extended. This funding will include more funding for our schools.

Dr. Ahern spoke about the snow day last week. She thanked all the staff for what was done for that day and spoke about some of the fun that was incorporated. She acknowledged that Beth Simon will be leaving as the secretary for the School Committee.

Ms. Stokes asked about the funding.

Dr. Bergen also asked about expenditures we could use the money for.

II. Guests/Presentations

A. ECDC Highlights - Kelty Kelley

Ms. Kelley shared a presentation about ECDC, the integrated public preschool. She spoke about the students and how the staff interact with them and how the students interact with each other. She shared what they do in some of the classrooms and how they communicate with the parents.

Mr. Keenan appreciated all the information. The SC members thanked Ms. Kelley.

B. Performing Arts Events - Diane Plouffe

Ms. Plouffe shared some highlights from the music department from this year as of today. She shared a slide presentation. She introduced the music staff from all the schools. Ms. Plouffe spoke about new safety guidelines for the rest of the year.

SC members enjoyed the presentation and how they are keeping the performances going.

A. School Calendar Draft - 2021-22

Dr. Ahern shared the school calendar for next year and the first day of school will be Tuesday, August 31.

B. School Reopening Status Update (as of 12/18/20)

Dr. Ahern shared the metrics on our status on COVID and Franklin became red. She spoke about how she keeps in touch with the health department.

She spoke about teaching and learning and working with literacy specialists and department heads as we move forward. She said that the survey for K-1 has been closed. She spoke about switching the instruction mode after the break and will wait to see what the metrics are.

Dr. Ahern shared a strategy on how they will be taking in COVID reports from families and staff. She stated that Monday, January 4 will be a remote day for all Schools.

Dr. Ahern spoke about the flu vaccine and how this requirement has been extended to February.

Mr. Keenan stated he liked the idea of asynchronous Wednesdays for the high school and when that might happen. He also asked about surveying other grades.

Dr. Ahern responded that they are still working on a date for that. She stated there are no surveys at this time so as not to overwhelm the staff.

Ms. Pond-Pfeffer stated that the school department surveyed the parents and not the staff and they should.

Ms. Spencer asked about the number of cases of COVID and asked about the results of the K-1 survey.

Ms. Stokes spoke about concerns about coverage for the schools and how they are being handled.

Mrs. Goodman spoke about the pay for subs.

Dr. Ahern stated that the schools have building subs and ESPs that will be assigned and times when Principals and Assistant Principals are in classrooms.

Ms. Stokes asked about what other districts are doing with full time for K-1.

Dr. Edwards reached out to other districts regarding this.

Dr. Bergen stated the remote day after vacation will allow schools to make sure they are safe. She asked about the timeline for CORI checks for new employees.

Donna Grady said she did agree with the one day for remote but the one day may not be enough for the nurses to ensure that the school is ready. She asked to consider that we may need to have more discussions on this and having remote for a longer period of time.

Gayle Melko reiterated that the asynchronous learning on Wednesdays for FHS is helpful but to please wear your masks and social distance because it is scary to get the COVID emails.
