a. Policy - First Readings

I recommend moving the following policies to a second reading at the next meeting:

i. (NEW) INJDD - Social Media Policy

Mr. Giguere - The first is an updated version of the social media policy. Thank Steve Sherlock in helping us define the policy.

We started by defining social media and to discuss using this in a responsible manner.

The first section describes the privacy of content. They cannot discuss anything from the district and minors cannot be on the sites without permission.

Online streaming can't be done without permission from the Principal. We caution folks that they speak for the district and they should exercise good judgment as an employee.

The third is for professional use and should be used for professional use only. We can monitor content on those accounts. Also with that they should not post anything political, religious or fundraising.

The personal social media, they have rights to have accounts they can violate state or federal law of speech. The final segment has clear boundaries between both accounts.

The fifth is contact with students that they should not fraternize with social media, friending following or liking.

The class or team should go to all members of the team, no private cell phone use.

The final section discussion is on using social media use during work time, they can use if they are using it for work. Social media private accounts are prohibited.

If there is a family member in the district, you can communicate with them.

Ms. Scofield - Thanks to everyone who provided input for this. It worked out great.

Mrs. Feeley- There are occasions that I had to call parent from home because of their time, but if you need to reach them when you are at home, can you use your cell?

Dr. Ahern - We would like the staff to use school issued devices, so not to give out numbers.
