Dr. Ahern - I have a couple of things to add. We are in MCAS testing season, we also have students in grades 3 through 8 taking them as well. The science exams are coming up for grades 5 and 8 and will be taken online for the first time. We want to wish all high schoolers good luck in their AP exams.

It is teacher appreciation week and I want to publicly acknowledge the staff for their hard work and dedication to our students. They are outstanding and deserving of all our appreciation not only this week but throughout the year. Thank you.

Activities are being planned for all schools and the parent groups are supporting our teachers.

The third is the Mass Association of School Superintendents has their spring meeting next week. Mr. Light and I will be attending. From the Fall meeting, the keynote speaker, Steve Vinter, the head of Google in Boston. He will speak on the emergence of computer science and how it changes our lives. It follows up with the theme of computer science and policy of the state and coming to understand how influential computer science is. # 2. Guests/Presentations

a. Transition Program (Students age 18-22) – Pam Myette, Amanda Notz, Carol Merchant

Mrs. Dixson - The strive program has been here for a long time and is one of the crown jewels of Franklin. We have students transitioning from age 14 to age 22. We want to focus on what they hope to become post high school. Most of the students graduate and some with more disabilities need more support and STRIVE is designed to help them with this.

Ms. Myette - The program is to take the goals from the IEP and create a wonderful functional, academic and vocational skills program for them. It is a hard task. The students have physical and emotional needs. This has to be created for each student. We expose them to all sorts of skills. We are trying to get them to think about what they want to do. We have over 100 general ed students who participate in Best Buddies. As as I said, Mrs. Notz has done a great job. Mrs. Merchant has been wonderful and this is her last year. She works with the merchants in surrounding areas to get work for the students. We work with agencies in Massachusetts to help us with these students and look at what the needs are. DDS will help when students need more assistance.

Ms. Notz - In my class, I do functional academics like budgeting, money, fraction in cooking, learning how to take a bus, life skills, cleaning, laundry, shopping and leisure. We try to expose them to leisure skills. We do jobs in the community. Everyone has a volunteer job in the town.

Ms. Merchant - You see a list of community partners. One of the main reasons is to thank the businesses that partner with us. They take great pride in their work and help them build confidence.

Ms. Notz - Some of the opportunities are at the Big Y doing various jobs.

Ms. Merchant - Meals on Wheels, this is a wonderful opportunity for the students to give back. They work in the kitchen, learn how to read a chart, get ready for delivery, they help portion meals. Break time has proven to be a great asset and they get to practice social skills.

Ms. Notz - One student works at Judy's Florist. She helps getting the flowers ready. We have students work at Shire Bookstore.

Ms. Merchant - Stony brook was a great opportunity for students to work in nature and do various jobs. At Froyo, they get to learn what goes on behind the scenes. They love this job. They learned safety with knives, how to sanitize, they cut the fruit and put the containers out. One of the students got a paid position. Summit medical apply non-skid strips for wheelchairs. The students must keep their area clean. They do get paid for this and a graduate was hired.

Elizabeth Bagels was one of the first to help us. Jen did not hesitate to help our students. They label bags, they prepare the to-go items, and help clean. This is a paid position.

Ms. Notz - At the Bellingham library, they work to help keep the shelves organized

Ms. Merchant - Kohls has worked with us and hired a graduate who has worked there 5 years.

Ms. Notz - At the YMCA, they wipe down mats, greeted the customers. Chili's restaurant - they help with set-up and opening, and they do food portioning.

Ms. Merchant - at Walgreens this student was trained and hired by them and is still employed.

The Hampton Inn, has a former student who worked in the front lobby and keeping it clean.

Pure Hockey was a high interest site for some of the students. They stocked items and worked on the floor

Ms. Merchant - All of our students go out during the day and work with a coach. If they are hired, then they go by themselves. We start out as volunteer and then it can transpire to a job. We want them to learn general skills. Most students don't work more than 2 hours because we want to work with them at the school. Some work full time after they graduate.

Ms. Feeley - Do any of the students get involved with the students at schools?

Ms. Myette - Yes, they do.

Ms. Notz - We want to do an integrated Art program and we currently do integrated health.

Dr. Bergen - We appreciate this. Is everything funded and do you have grants?

Ms. Notz - We got the eagles scouts to help out and we did get grants to help.
