Dr. Ahern - I would like to congratulate our new School Committee. Speaking of snow I did make the decision of emergency bussing for tomorrow morning, wind chill of 2 degrees. I sent out a regroup about bus service. Students who don't have bus privileges can be picked up by the drivers. We do not anticipate a need for afternoon busing.

I want to share a recap of last week's Massachusetts School Supterintendent's meeting. I enjoy going.

Norman Orenstein was one of the speakers and reflected on making policy. Derek Gay remarked on Diversity for the 21 Century.

I attended breakout sessions throughout the day. There was compelling information on how to brand your schools and how to enhance communication. We learned more about the strike in Dedham. I attended a session with MAPLE, which we belong to. The last session was on evaluating the superintendent. It was a great conference.

An upcoming event is our professional status celebration for our educators. It is awarded after 3 full years of successful employment in the district. It is a high bar to obtain this status.
