A. FHS Student Representative Comments

Akash Shetty - President of Senior Class. He shared his thoughts and the student's on remote learning that it can be isolating but has had a positive impact on him.

Katie Garrigan - Senior, Class Treasurer, and she also shared her thoughts on remote learning and how some students could get lost.

Nipun Goel - Junior Class President again shared his thoughts and said that it is a mixed bag and commend the teachers for all their work.

B. Superintendent's Report

Dr. Ahern - She shared information about health metrics and data regarding the reopening of the schools. She stated we are below average of COVID cases. She informed the public that we are ready to return with all the protocols in place. She spoke about the FHS and how they will have three cohorts to come to school in person and have the hybrid program for them.

She provided an update on the ultraviolet project for the schools and it is an additional precautionary measure.

Dr. Ahern provided an update on technology and the new chromebooks which are due any day. She spoke about how funds from the fund for COVID will help with any technology issues. She stated the bandwidth for internet will be looked at and monitored as more students come back to schools

Dr. Ahern spoke about the free meal program and the continuation of this program.

Ms. D'Angelo asked about any staffing concerns.

Dr. Ahern stated that it continues to be a concern.

Mr. Keenan asked about feedback about athletics.

Dr. Ahern stated that the students were masked and working on safety protocols.

Ms. Scofield asked about the PPE.

Dr. Ahern stated they all have proper PPE at the schools.

Ms. Spencer asked about the process of changing how a student may want to change their learning model (hybrid/virtual).

Dr. Ahern gave a brief explanation.

Ms. Stokes asked about updates on the reopening task force.

Dr. Ahern stated that they are putting the team together.

Ms. Stokes asked about VLA and literacy and math specialists.

Dr. Ahern spoke about these positions.

Dr. Edwards also spoke about these positions in school learning and virtual learning.

Ms. Stokes asked about the Kindergarten and the long screen times and would the day get shorter for half-day kindergarten.

Dr. Ahern stated that they were not currently looking at that but instead are looking to balance screen time with low tech options.

Dr. Bergen thanked Dr. Ahern about looking into laptops for teachers.
