Mr. Keenan spoke about COVID communications and wanted to expand on the policies from FPS. He also expressed as a parent that we need to follow CDC guidelines moving forward.

Mr. and Mrs. Benson expressed concern about having the younger students return to school in person more than two days. They also wanted to know if it was being considered.

Ms. Erlte also wanted to know how to get on the agenda for the next meeting and how to get the younger students back to school.

Ms. Gubka shared that she is also concerned about getting the younger students back to in person learning and how the hybrid is working for these students.

Ms. Hamling wanted to echo what the other parents are commenting on regarding the younger students.

A. FHS Student Representative Comments

Akash Shetty - He shared that the students are in the transition stage and the students are looking forward to getting back into school. He spoke about how he went in and did a video for the students and how the days will look at FHS. He thanked everyone for all the assistance with SATs.

Katie Garrigan - She thanked everyone for all their hard work. She stated that the students were glad the date was moved up.

Nipun Goel - He provided an update on sports and that they are doing great. We are broadcasting via zoom. He went on to thank Mr. Hana and Mr. Angelo.

B. Superintendent's Report

Dr. Ahern - She shared that October is National Principals month and wanted to acknowledge them and their hard work and added that the Assistant Principals are also doing a wonderful job.

She spoke about how the past couple of weeks have been going and she is proud of the FPS staff.

She shared a slide show of the schools look and how the classrooms look.

Dr. Ahern provided an update on the budget.

She spoke about the COVID rate and how Franklin is in the yellow designation and we will continue on the current plan.

She relayed information about communications about awareness with the new information from the Department of Public Health and she will keep the public updated on any information.

Dr. Ahern spoke about professional development for the staff which is November 3 and will allow faculty to report to school or work remotely on that day.

Ms. D'Angelo would like to incorporate parent feedback with a survey.

Mr. Keenan commented on the community comments and how the other towns were able to do this.

Dr. Ahern provided some information on this.

Ms. Scofield asked about budget development and if a School Committee member was attending the Town Council meetings.

Ms. Spencer asked about whether teachers might receive new chrome books. She also spoke about COVID communication and how important it is.

Ms. Spencer thanked the teachers.

Ms. Stokes asked about increasing school time for the younger students.

Dr. Bergen spoke about how the Digital Integration Specialists will provide us with a brief presentation.

A. Comprehensive Facilities Analysis Report -- Craig Olsen, Kaestle Boos, Inc.

Craig Olsen from Kaestle Boos, provided a presentation regarding space analysis in the Franklin Public Schools capacity through qualitative and quantitative studies.

He stated that this report is to be a tool to develop a master plan.

Ms. D'Angelo asked about the EA index and is there typical research used for this?

Mr. Olsen replied that there is.

Ms. D'Angelo asked about the scenarios and boundaries.

Mr. Olsen stated that he did not recreate boundaries.

Ms. D'Angelo asked about if they propose redistricting?

Mr. Olsen stated yes, you could but it could be difficult.

Mr. Keenan asked about factoring in the level of funding per student spending?

Mr. Olsen stated it doesn't take into financial standpoints.

Ms. Pond-Pfeffer asked about educational adequacy.

Ms. Spencer asked about the closure of DT as not viable but others looked that way.

Mr. Olsen stated that one is viable and one is not viable.

Ms. Spencer asked Dr. Ahern about updated numbers reflecting the 2020 census?

Dr. Ahern stated that they will look at enrollment and the 2020 census.

Ms. Spencer asked about title one funding.

Mrs. Goodman stated it will follow the students.

Ms. Stokes asked about DT and the driveway.

Mr. Olsen defines a driveway as whether a car can go through that area.

Ms. Stokes also asked about the no on-site drop off.

Mr. Olsen stated that he did not understand that when explained to him.

Ms. Stokes asked about how to raise DT's educational adequacy.

Mr. Olsen stated it was a small school but could use some renovation to make it more viable.

Dr. Bergen asked about immediate need and the solutions?

Mr. Olsen stated the immediate solutions would help solve the capacity.

Dr. Bergen stated DT was renovated in the 1970s.

Ms. D'Angelo asked about incorporating how to increase the EA index.

Mr. Olsen said that they did look at that.

Ms. D'Angelo asked about community space and curriculum philosophy and what the group could do moving forward. She also asked about building maintenance costs.

Mr. Keenan stated that it looks like there is some feasibility to update DT.

Mr. Olsen stated that they look at data and feasibility.

Ms. Pond-Pfeffer stated that we hired this company to help figure out long term goals.

Ms. Spencer asked about DT and Parement listed as being closed for immediate need.

Mr. Olsen stated it is based just on data at this time.

Ms. Stokes reminded the community that no decision was made at this time. She asked if we are focusing on just DT or all the other schools as well.

Dr. Bergen stated it was for DT at this time and then for a long-term plan.

Dr. Ahern stated that the committee thought about retiring DT and then look at some long term facility sub committees.

Brian Bodiya, Oak St, commented on the goals and projections of the presentation and wanted to know about time frames.

Rebecca Ballinger, Charles Drive, commented on following the process and that the two schools are trauma schools.
