They did a workshop with Ashes in the Snow along with the author, Ruta Sepetys. They MC'd the luncheon and award show. They also did a workshop in family and community engagement. They had an unbelievable time at the conference with major contributions.

We are proud of our FHS science department head Bill Bobrowsky who was honored recently by being inducted into the Massachusetts Science Educator's Hall of Fame.

B. ECDC Developmental Summary

Mrs. Kelly - I also want to thank you for your commitment to your effort and openness. There have been a lot of challenges these years and you have been wonderful.

I have a development summary about ECDC and to align all of our policies with the rest of the district. It is not a report card. It is a development summary, it is a picture of where they are but touches on math, literacy and science. What you have before you is a reflective process and we reflected after each trimester what you noticed and what it didn't do. There were gaps they needed to report. So we did that last year through each marking period. It is not a sit down test. There are small group data, one-on-one data and classroom data. We created this wonderful rubric. We are ready to go forward with this for the first trimester. We understand this is a work in progress and after families have it and have done the process of assessing, we will ask what worked and what didn't work.

Mrs. Feeley - Do the parents need any help or guidance on this? Will they get nervous?

Mrs. Kelley - This is our biggest issue. Parents may take this as how is my child doing and how do I help them. A letter will go out to the parents, to help them understand it is a snapshot and you may see something your child does at home and not at school. The rubric will be used for conferences in December. This will allow us the opportunity to discuss it.

Mrs. Scofield - Please highlight the development summary starts with SEL and the foundation by the inclusion.

Mrs. Kelly -When we selected our curriculum it was because it could be inclusive and meet a wide variety of levels. We have children who develop at different paces. We wanted to make sure the report could be reviewed by everyone. This rubric will apply to every child. The foundation, we had guidance for two standards and SEL is very big, and then english language arts has fewer and the others get fewer and fewer. We make sure that what we are doing to enhance one skill doesn't stress with another skill.

Dr Bergen - I was drawn to the SEL skills. It is the same conflict as some of the high schoolers need as well.

Mrs. Kelly - When I do my volunteer trainings, I make sure to tell people what skills you see and make sure the children are taught correctly according to their developmental abilities.

Mrs. Feeley - My concern about the student survey, there can be frustration after the MCAS and it may be inappropriately represented. It may not reflect correctly.

Dr. Ahern - We can look at that. The survey has a lot to celebrate and the survey showcases a lot of positive parts. The metric is around growth and taking this as a baseline and growing. Any source of data is limited. The DESA scores around SEL skills will help support the data as well.

Mrs. Schultz - On the staff well being, I would like to hear more about that. Will you be surveying them?
