d. Superintendent's Report

Dr. Ahern - I have a few things to share. The first is a congratulations to the music students and faculty for the MICCA performance over the weekend. We are very proud of them. The Franklin High School symphony and repertory orchestra have been invited to perform at the Mechanics Hall in Worcester. A huge congratulations for an outstanding performance in all our music programs.

The second piece is the professional development day next Friday, April 6. Some schools will be doing what they have been working on in the past with school improvement goals and some will be working on new agendas.

ECDC will work with teaching strategy goals. Davis Thayer and Parmenter will have theirs with Lesley University becoming trauma sensitive schools.

The Jefferson Elementary School will have a Middlesex Partnership for Youth training and do workshops and it will be on the impact of anxiety for students. They are doing a book study of her work. Keller will have three sessions, the first being on how educators can support students who are

gender transitioning, best practices for working with English learners and one on positive core culture within the school.

Kennedy elementary is focusing on strategies on English Language and Arts and Reading and in grades 3 - 5. Oak Street will continue with their committee work. ASMS and Remington will continue with Keys to Literacy. HMMS will break into groups to work on the development for fall programs. Franklin High School will be working on grading practices and reporting systems and the school nurses have CPR training.

2. Guests/Presentations

a. FY19 Budget Hearing

Dr. Bergen - Is there a motion to open the hearing?

Dr. Ahern - We will start with a presentation regarding the FY19 budget. We began this in February and centered the work on the vision and mission of the FPS and really had the work based on this as well as the district improvement goals.

The process to date is summarized and had a series of meeting over the past few months. We worked with Town Council and central office administrators and principals for building-based budgets. We began the process in the fall and have continued meetings throughout the year. Please refer to the budge books in front of you. We will be applying revolving funds to support the budget.

Mrs. Goodman - We look at the foundation budget and recognize the Massachusetts laws and the minimum amount necessary to provide an adequate education in Massachusetts. There are a couple of key factors that the State looks at. This year the rate is \$10,163 per student for Franklin. Then they look at how much each town can afford and then they take the total budget and subtract the local contribution and then the State funds what they can.

We are proposing a budget of \$63,235,000 for the FY19 with an increase of \$3.5 million. Added to that we have the revolving funds we are going to use for the FY19 expenses. We will have less revolving funds this year. They will be non-recurring after this year.

We will have \$1.391 million in Federal funding for special education.

We talked about some assumptions and an increase in the Town allocation and that looks like \$3\$ million increase from last year. The health care increase will be in the 4% range as opposed to 8%.

Dr. Ahern - As a reminder the budget is a level-service budget but there are some needs that we will support. We will review the counseling program and make recommendations moving forward. We have seen success with the William James partnership and we will include \$8,500 in the budget for this. We want to pilot the DESSA assessment for SEL students and target interventions for students.

In terms of staffing we will look at this across the district and have increases and decreases as well but it will be budget neutral. We have put in a need for a partner classroom at ECDC and this will generate revenue. We will also have a partnership with NECC for students with autism and service students within their local school. This will help these students stay in their schools and not have them go out of district. We proposed some FTE within student services.

Mrs. Goodman - When we look at the total spending we have an increase of 4.98%, we have an increase in the revolving accounts.

You can see based on roughly 9.5% is contributable to red part, the revolving account.

As a whole the \$63 million -- 76% is going to salaries; 9% to health and medicare; 7% to out of district;, 4% to transportation and 4% to other expenses.

So in terms to the State average our total for FY17 is \$14,011; the state average is \$15,932. We will be below that. In terms of the categories of expenses, we are below in most categories and we are above in professional development. I will point out that in terms of insurance we are below the State by 33%. We work to keep the healthcare premiums down.

Dr. Ahern - Some recommended next steps is to have a motion at the April 10 meeting to adopt the budget and bring this to the Finance Committee and the Town for adoption. Looking to FY20, at some of the things that did not make it and could be considered long term. We are looking at interventionists, technology integration specialists K-12 STEM coordinators, K-12 Humanities Coordinator, staffing increased due to enrollment, health/PE FTE at middle schools. We will have considerations for the new plans and they are declining enrollment, increasing high high school enrollment. We are looking at current places being built for families and could increase enrollment in certain schools.

Any questions?

Ms. Scofield - A question on the \$15,000 for the study of the counselor. How long will that take? Is the need there?

Dr. Ahern - Great question, the idea is to have information to build into the FY20 budget. This will be to support some counselor positions in those buildings and a conversation to be had at the leadership team. We want to look at the models and how the buildings are staffed and come up with a system for all schools and have the right positions applied across the board.

Dr. Bergen - We are going line by line through the budget.

From a parent from Troop 99 - In one of the slides we are spending 54% of teaching materials and technology, we should be spending more on technology and why is it so low?

Mrs. Goodman - The majority of our budget goes to salary and health care and there is a small portion that goes to instructional materials, we spend a lot less than other towns do on instructional items and we don't have additional funding for that.

Jarrett Schmidt - How do you decide what goes in the budget and what doesn't?

Dr. Ahern - It is a big process. That is a great question. It is an enormous collaboration in my office with all the staff and School Committee and the staff at the schools. We try to understand the wants and needs. We meet with the Town and

what they would be willing to support. We get our instructions and then take that and work with that. Then we come up with recommendations and report on it.

Dr. Bergen - Now we go line by line through the budget

The School Committee went through the budget at 7:40 PM.

Dr. Bergen read through each area, if you would like to hold for discussion please say so.

Mrs. Douglas - Hold on assist superintendent's office.

Ms. Scofield - Hold on Legal services.

Mrs. Goodman - The Department of Education states that their function is reporting under curriculum and instruction. They are both here just under a different category.

Ms. Scofield - What does \$130,000 gets us?

Mrs. Goodman - It is our attorney and what we need them for.

Mrs. Schultz - Why is that under School Committee?

Mrs. Goodman - It is contracting an attorney.

Ms. Scofield - Out of district, how much is that out of the goodness of our hearts? How much is not?

Mrs. Goodman - None. We must supply it.

Ms. Scofield - The information provided is great. Miriam, thank you. It has great back up.
