- II. Approval of Minutes
  - a. Full Committee Meeting -- 12/18/18 motion by M Linden, second by MJ Scofield, approved (8-0-5 (Grady, Angelo, Harrington, Ambrose, Gould))

- III. Updates from Subcommittees- None
- IV. Update on Communications S Ahern reported that the parent forum is scheduled for January 30, 2019 at 7pm with a sleep expert from Harvard University and with a panel of pediatricians. S Ahern met with Dr. Bergen, School Committee Chair regarding a target date for a presentation to the School Committee from the School Start Times Advisory Committee on their findings. Presentation will take place on March 26, 2019. Two critical pieces of information will include a presentation and a report synthesizing and summarizing the work the committee has done. The steering committee can collate information from each subcommittee and draft the report and presentation.
- V. Initial review of survey data- S Ahern reviewed the survey responses and indicated there were, generally, 1,473 responses. Responses were based on scenarios A and B below:

Members of the committee discussed the hi-level results in smaller groups and then a full group discussion was held. Disaggregating the data will be helpful and S Ahern will review and report back to the full committee with further data. Separating elementary from middle and high school level would be helpful. Awareness was raised for the impact on families with students with special needs as to after school therapy appointments (speech, OT, PT, counseling, etc.) Concern was noted for the rate being charged for Solutions and the rate impact if hours were extended. S Ahern will follow up with Chris Nayler, Director of Lifelong Learning.

Further analysis will be forthcoming at the next meeting. Faculty and staff survey might also be reviewed at the next meeting. Perhaps the Employee Relations Subcommittee can do some analysis first
