# Superintendent's Report to School Committee November 26, 2019 School Committee Meeting

#### Student Opportunity Act Signed into Law by Governor Baker Today

Governor Baker signed the Student Opportunity Act into law earlier today. As noted previously, the bill provides for:

- Increased funding for areas recommended by the Foundation Budget Review Commission's 2015 report, including increased funding for employee and retiree healthcare costs, special education, English language learners, and students from low-income households.
- Providing additional state financial support, to be implemented over a number of years, for public schools through charter tuition reimbursements, an expansion of the special education circuit breaker, additional funding for school guidance and psychological services, and lifting the cap on Massachusetts School Building Authority spending.
- Establishing a 21<sup>st</sup> Century Education Trust Fund for districts and schools pursuing creative approaches to student learning and district improvement; a Data Advisory Committee to help districts with strategic planning and resource allocation; and a Rural Schools Commission to investigate low and declining enrollment in rural schools.
- Requiring schools and districts to develop and publish plans for closing opportunity gaps, and requiring the Department of Elementary and Secondary Education to publish district-level data on student preparedness for post-graduate success in college and the workforce.

We are in the process of understanding, with greater detail, the impact locally on Franklin and identify the following ares:

- As a minimum aid community, we do not anticipate an increase in Chapter 70 funding as a result of the implementation of the FBRC recommendations. The bill, however, does set minimum aid to be \$30, which is the same amount as FY 20 and higher than amounts received in recent fiscal years.
- We anticipate additional financial support through the Circuit Breaker Reimbursement, with the inclusion of out-of-district specialized transportation (beyond a threshold level), which had previously not been included. This is proposed to be phased in over several years.
- We anticipate a small amount of additional financial support of Charter School Tuition reimbursement, which had not been fully funded in years past.

 Opportunities for competitive grants and additional flexibility through the 21st Century Education Trust Fund.

#### **Monthly Davis Thayer Facility Analysis Update**

The district-wide demographic study, originally announced in the October update, is under way. We are still anticipating the results of that report to be ready in January.

We are still working to find a consultant and define the scope of the facilities adequacy study of Davis Thayer and functional space study of all schools across the district.

The next update will be issued in late December.

### Visit to Franklin Newcomers Meeting on November 20

I had the pleasure of attending the Franklin Newcomers Meeting last Wednesday as a guest with Town Administrator, Jamie Hellen. I gave a few remarks, which included our District's Strategy for Improvement and our Connect With Us opportunities. Additionally, I described how educating students today has changed with the:

- Increased needs students come to school with, including more complex needs
- Increased expectations that schools serve as hubs of social services in addition to the traditional mission of academic instruction
- Rapid advancement of technology driving big changes in major industries, resulting in a need for a dynamic education system that is preparing students with both academic and SEL skills for this rapidly changing, technologically advanced world
- Pressures students face today including social media as well as the availability and prevalence of substance abuse.
